



WHEREAS, the Court, having first adopted its budget for fiscal year 2018-2019, now desires to establish a property tax rate to support the 2018-2019, budget:

NOW THEREFORE, on motion made by Commissioner David Ford, seconded by Commissioner David Vincent and a vote taken with Commissioner David Vincent voting yes, Commissioner David Ford voting yes, Commissioner Chad Hicks voting yes and Commissioner Butch Owens voting yes, County Judge Gordon voting yes the Commissioners' Court of Hartley County, Texas, hereby orders that ad valorem taxes on property located in Hartley County for the year 2018 shall be levied and collected from property owners at the following rates, based on each One Hundred Dollars (\$100.00) of assessed valuation:




THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATION THAN LAST YEAR'S RATE.
