# HARTLEY COUNTY 2015-2016 ADOPTED BUDGET

This budget will raise more revenue from property taxes than last year's budget by an amount of \$164,959.00 which is a 6.96% increase from last years budget. The property tax revenue to be raised from new property added to the tax roll this year is \$61,115.56

**WHEREAS**, on this the 14th day of September, 2015, The Commissioners' Court of Hartley County, Texas , convened in Regular meeting with the following members present:

**WHEREAS**, the Court, having first adopted its budget for fiscal year 2015-2016, now desires to establish a property tax rate to support the 2015-2016 budget:

**NOW THEREFORE**, on motion made by Commissioner Owens, seconded by Commissioner Vincent and a vote taken with Commissioner Vincent voting yes, Commissioner Ford voting yes, Commissioner Hicks voting yes and Commissioner Owens voting yes, the Commissioners' Court of Hartley County, Texas, hereby orders that ad valorem taxes on property located in Hartley County for the year 2015 shall be levied and collected from property owners at the following rates, based on each One Hundred Dollars (\$100.00) of assessed valuation:


0.365000 Maintenance and Operations

**FURTHER**, that the rate as set forth by this Order shall be effective upon the adoption of this order, and that the Hartley County Appraisal District shall cause tax statements to be prepared and mailed to each of the taxpayers as listed on the Tax Rolls of Hartley County,
